A 20% late fee will be further assessed every 30 days of nonpayment thereafter until your account is brought current.
- 3. Momentum Warehousing LLC reserves the right to hold the release of any or all of your goods for nonpayment or partial payment for any or all services provided.

Following 90 days of nonpayment or partial payment, your items will be considered abandoned and Momentum Warehousing LLC may confiscate any or all of your goods in order to compensate for any or all services provided. Late fees will continue to accrue indefinitely until your account is brought current.

# **Termination/Access Restriction**
